Students Feedback Report

Session 2017-18

To improve the quality of teaching and learning process feedback is taken from all stake holders. Students are very important part of teaching learning process and all the activities of the college are organized as per the need of students. Their feedback is very important for the improvement of the college. Feedback is has been taken from all the Students on three point rating scale 1-3 i.e. 1. Strongly Agree 2. Agree and 3. Disagree. There were eighteen closed ended questions in the feedback questionnaire. Most of the students were satisfied with the availability of books and reading rooms in library. Students also found library and office staff cooperative. Students were satisfied with functioning of grievance redressal cell and placement cell of the college. Equipments in labs have been reported in good in number and condition. Students reported that infrastructure for disabled people need improvement. Students also reported about the non functioning of internet facility and cleanliness of washrooms. Though students were satisfied with display of attendance but to attain maximum attendance of students measures should be taken.

Teachers are very important stake holders so their feedback and suggestions are very helpful in improvement of the college. The feedback is received from all the teachers on three point rating scale 1-3 i.e. 1. Strongly Agree 2. Agree and 3. Disagree. There were ten closed ended questions in the feedback questionnaire. Most of the teachers found syllabus taught by them is good blend of theory and practical. Teachers agreed with that the college has given them full freedom to adopt new techniques in teaching and examinations are conducted well in time. Teachers suggested for the improvement of number of books in library. Teachers agreed that Environment in the college is conducive to teaching and research process and the college provides adequate opportunity to faculty members for upgrading their knowledge and skills. They were satisfied with students engagements in class rooms and the infrastructure of college. Teachers found grievance redressal effective and non discriminatory.
